Due to changes in insurance requirements at some of the venues that NIMEA utilizes throughout the year, we had to acquire a new General Liability Policy that includes Sexual Abuse and Molestation coverage. The Policy includes requirements for all our members that have student contact on behalf of NIMEA, our Regions, and our Affiliated organizations when sponsoring an NIMEA activity. These requirements include Criminal Background Checks, Sexual Abuse Registry Checks, and Abuse Training. These will need to be completed before any volunteer can participate in Region or All-State activities.
